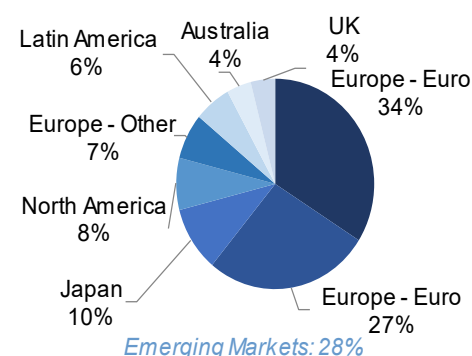

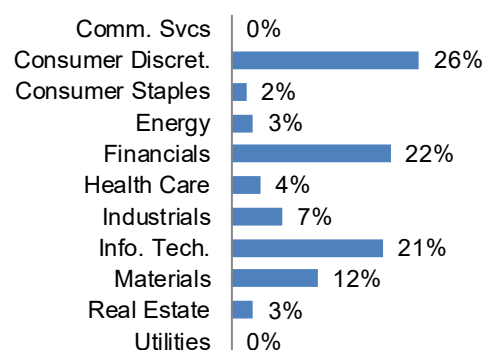

The MSCI ACWI ex-US Value Index captures large and mid cap securities exhibiting overall value style characteristics across 22 Developed and 24 Emerging Markets countries. The value investment style characteristics for index construction are defined using three variables: book value to price, 12-month forward earnings to price and dividend yield. ### Definitions:

**Market Cap - Weighted Average** is the average market capitalization (market price multiplied by the number of shares outstanding) of companies held in the portfolio weighted by security weight. **Market Cap - Median** is the midpoint of market capitalization (market price multiplied by the number of shares outstanding) of the companies held in the portfolio. **Return on Equity - 5 Yr Avg** is the weighted average of the previous 5-year ROE numbers of companies held in the portfolio. **Price-to-Earnings - FY1** is the 12-month forward earnings estimates of companies from third-party sources as of the reporting period. Estimates reflect a consensus of sell-side analyst estimates, which may lag as market conditions change. ARGA uses weighted harmonic average to calculate the ratio of the portfolio as it is the most appropriate measure for ratios and rates because it equalizes the weights of each data point. **Price to Book** is a valuation ratio of a company's current share price compared to its book value. ARGA uses weighted harmonic average to calculate the ratio of the portfolio as it is the most appropriate measure for ratios and rates because it equalizes the weights of each data point.
